AWARD CRITERION	Given to a graduate who has made outstanding contributions to the College of Law, defined by either time or financial resources. The recipient should reflect a continuing commitment to the successful growth and development of the College.
AWARD ELIGIBILITY	Each nominee must be a graduate of the Georgia State University College of Law.
NOMINATION PROCESS	Nominations will be reviewed by a Selection Committee composed of members of the GLC, one College of Law faculty member and one member of the Board of Visitors. The selection process is scheduled to conclude in February 2010 and the recipient and the community will be notified shortly thereafter.
NOMINATION DEADLINE	<p>Nominations will be accepted through Friday, January 29, 2010. Nominations may come from any source.
